The purpose of this meeting is to review the financial status, vote on the annual assessment, elect board members and act upon any other water related business that may be presented before the members at the meeting.



# **UNABLE TO ATTEND THE ANNUAL MEMBERS MEETING?**

## Appoint a Proxy

Each member in good standing shall be entitled to vote, or vote by proxy, on any motion. At the election for directors, every member entitled to vote shall have the right to vote, or vote by proxy for as many persons as there are directors to be elected.

Members are entitled to one vote per paid membership held within the Association.

## STATE OF WATER SYSTEM OPERATION AND MAINTENANCE

The water system operation and water testing are in full compliance with ADEQ standards.

On April 29, an alarm was triggered through OmniSite indicating low tank levels and a reduction in water pressure. The system was shut down while members of the Board investigated the source of the problem. A large leak was detected on lot 12 resulting in a constant draw on the pump and reduced water pressure, while causing a substantial drop in the tank and well levels. Water supply to the lot was terminated and the water system was turned back on. The owner of the lot was provided with a notice to repair.

Potential leaks were identified on Lots 17 and 31 and the water supply to the lots was terminated. The members were notified and are addressing the issue.

The back-up generator at the well site was installed on September 16 and was brought online September 30.

The painting of Tank B was completed on June 18th.

The relocation of the valve at lot 13 is scheduled to be completed this summer. The work is necessary to protect the underground pipe which has been jeopardized due to normal deterioration and depletion of road material.


One of the two pressure transducers is measuring pressure slightly inaccurately and will be replaced. Projected cost is \$300.

As a part of preventative maintenance, a distribution line flush will be conducted if needed.

# WATER LEAK?


To preserve the community's water resources and integrity of the system, we ask that you promptly address any water leaks on your property. Please turn off the water at the street valve until repairs are complete.

If you notice a leak within the unit, please report it to ccp2community@gmail.com or call 602-723.6577.

What is the water association responsible for? The water association is responsible for the water mains in the ground and usually for the communication pipe. This is the part of the service pipe leading up to your property boundary from the mains.

What are members responsible for? It's a member's responsibility to maintain the

supply pipe. This is the section of the service pipe from the boundary of your property – usually where the stop valve is – into the property itself.



**Responsibility for damaged water pipes** The diagram shows how the water supply is connected to your property, what the different sections of the pipe supplying the water are called and who is responsible for them.

## **BOARD OF DIRECTORS MEETING**

### May 25, 2024 | Clear Creek Pines Water Well Users Association

The Clear Creek Pines Water Well Users Association Board of Directors met on Saturday, May 25, 2024. The purpose of the meeting was to review the current state of water quality, review the association's financial status, discuss operational concerns and planned repairs and preventative maintenance, and to discuss other business related to the water system. The following actions and decisions were accomplished:

Our balance sheet is strong, and we have no current debt. A total of \$1750 in water assessments remains outstanding. The Board is actively pursuing action to collect the past due payments in accordance with the Association's Bylaws.

The Board is working on adding insurance coverage for the newly installed generator.

Our water quality continues to pass monthly tests without any water sampling failures.

The fourth annual financial review of the Association books will be conducted August 31, 2024 by the appointed Oversight Committee (Water Quality Liaison, Randy Garrison and Vice-President John Popp).

The current state of the water system, planned repairs and preventative maintenance on the well discussed in the meeting are outlined on the previous page.

# WELL SITE IMPROVEMENTS

A much needed coat of paint on Tank B was completed in June. Previously the tank was unpainted and galvanized and now matches it's sister tank, which was installed in 2020.

The back-up generator at the well site was installed on September 16 and was brought online September 30. Subsequently, Clear Creek Pines Unit Two experienced a number of power outages over the winter which caused the generator to move into operation mode. The generator operated as anticipated preserving power to the well system and pressure pumps.

## Happy Jack Man Wins \$25,000

Northern Arizona's first \$25,000 winner in the Arizona Lottery's Count 'N Cash game, which began at midnight, was Bruce H. Powell of Happy Jack.

Powell runs the Long Valley Service Station there and purchased the winning ticket from himself about 7:30 a.m.

"It's hard to believe, very hard to believe," said Powell. They were so excited, they drove halfway to Flagstaff before discovering they'd left half their things at home needed for a trip to Phoenix this afternoon to claim the check, he said. Powell said he would use the money to provide a college education for his four children, three of whom attend Winslow High School. The other is a student at Northern Arizona University. The rest of the money will be invested in the family business at Happy Jack, a station Powell has owned for seven years.

Powell said he was doubly surprised to be a big winner because business has been so slow this winter. He said he has only bought a few tickets himself.
